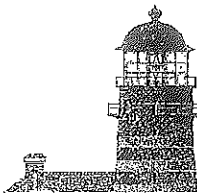

This application must be filed and the mooring fee must be paid to the Town of Lubec before placing a mooring in the waters off the Lubec shoreline. Only thereafter will the applicant be authorized to place a mooring in the water. Moorings will be placed at the direction of the Harbormaster. It is understood that the Harbormaster RESERVES THE RIGHT to move or remove any mooring if there is reasonable grounds to do so or if instructed by State / Federal agencies. Subsequent annual fees are due on the first day of the month following this application. It is the SOLE duty and responsibility of the mooring owner to conduct regular safety checks to ensure that the mooring is up to code and in good working condition. It is REQUIRED that every mooring have a swivel. Moorings may not be place in locations that hinder navigation. This mooring permit is issued to the applicant only and cannot be transferred to any second party without written consent from the Harbormaster and the completion of a new permit and payment of any applicable fees.

I, the undersigned, agree to supply adequate mooring gear of not less than what is set forth in this permit and also to maintain my mooring as set forth by Town Ordinance and States Statues that apply. In the event of transfer, sale or discontinuance of the mooring, the Harbor Master will be given notice of the same.
